- 1. **Other Contributions**: This is the contribution, €7,275, paid by SLU (not an ICAR member fee).
- 2. **Other income:** This is the contribution, €34,704, from FAO for the Letter of Agreement to jointly organise the ICAR-FAO Pretoria Symposium in South Africa in April 2015.
- 3. **Special project expenses**: Costs, €47,148, associated with travel, accommodation various for the ICAR-FAO Pretoria Symposium in South Africa in April 2015.
- 4. **Technical Activities Future ICAR:** 2015 Costs of €32,000 are associated with ICAR Brand understand Phase (€21,180) and Upgrade of ICAR Web to version 1.0 inc. other Technical IT support (€10,820).
- 5. Extraordinary Charges: This is the total amount, €5,675, of overdue fees which were accrued for three years and cancelled on 31/12/2015 according to our Statutes. Details include; One Full member (Peru RGZ) and four Associate members (Hadid

2.2 **ICAR 2016**

Appendix 2: ICAR Income Statement Budget vs Forecast 2016 (as of Dec 29th 2015). **Appendix 2: ICAR 2016 Income/Expense Notes (as of 29th Dec 2015)**;

- 1. **Staff and Consultants:** Groups Coordinator costs will be attributed 100% to ICAR in 2016. (In 2015 50% was to S-ICAR).
- 2. **Technical Activities Future ICAR:** This €69,500 is detailed under Section 3 of this CE Report, "Brand Project Plan and Budget 2016. Costs are associated with ICAR Logo evolution, ICAR Story/Presentation material, ICAR Web Version 2.0 and Revamp of Guidelines.
- 3. **ICAR Surplus Reserve**: ICAR has built up a surplus of €451,601 up to December 31st 2015. As an INGO the CE recommends we are bound to begin to use this to provide better services and value to our members. In 2016 we plan to do this by spending €69,500 in "Future ICAR" deliverables as opposed to the €30,000 budgeted. For Board approval see detail in section 3 below.

Appendix 3 and 4: S-ICAR 2015/16 Income/Expense Notes (as of 29th Dec 2015);

a. <u>Tags & Recording Devices</u>: The income from tests amounts to 28,835 Euro compared to 80,000 Euro budgeted. The reduced income of **51,165** Euro is due to cancelled tests or postponed 'til 2016 – namely Orion and Lactocorder which will now both fall into 2016. The next year 2016 was originally forecasted at 60,000 Euro which we now have upped forecast income to 90,000 Euro.

- b. **Certificate of Quality**: The income in 2015 amounted to 18,397 Euro some 8,397 Euro more than budgeted. The new Consultative Review pilots have been piloted and will be part of the 2016 and subsequent annual C of Q Audit schedules.
- c. <u>Identification Devices</u>: The problem highlighted by the end of September figures for ID income (which forecasted a year end position of €51k under vs budget due to poor uptake of our Recertification scheme), prompted the ICAR office to aggressively campaign and pursue our ID manufacturers for engagement with the new scheme.

A letter notifying them that their products that will be "De-Certified" by ICAR was sent and that letter plus associated follow up calls proved very effective. As a result the manufacturers reacted quickly and some 29 tests were submitted in the Oct − Dec period. This brought in some €75k in that period which meant our year end 2015 income for ID came in at €397k versus €385k budgeted with costs higher than budgeted due to test mix.

d. **SOLID EU:** The annual cost for SOLID project in December 2015 amounted to 27,711 Euro, which with our 20% admin overhead saw an income of 35,000 Euro in 2015.

3 Brand Project Action Plan and Budget 2016

ICAR Brand Project: In our November 20th 2015 Board meeting we ratified Milestone (MS) 3 "Understand phase" as well as having a good productive session with Joost, the board and staff on the ICAR "Story" development. In the intervening month Joost and Martin have worked on a plan of action and budget for 2016 – this has been presented to the Board's Brand Steering Committee on January 11th and feedback has been incorporated. 

Also Philippe sent on 2014 and 2015 raw PT data ICAR on 12th Jan 2016. Meeting proved to be very productive, executive summary of meeting;

a. Expert Group;

Appointment of Expert Group and identifying their first tasks/ priorities (SNP listing, file and content structure, rules for SNP exchange, permissions/authorisation). The Implementation TF felt that the Chair should have a connection with the Implementation TF and proposed Brian Van Doormaal as Chair for the Expert group. b. Other Tasks for PSE- Implementation Task Force (PSE-ITF);

- i. Which animals are submitted from the national level up? Not necessarily all animals target animals (egg. bulls in AI, ET donor dams, etc.) Service users will need to be able to request additional animals from the country the animal was born in.
- ii. Define authorities for usage of data and access rules
- iii. Define Service fee structure
- iv. Wording of service agreement
- v. Wording for contacting ICAR members to inform them of GenoEX PSE and for requesting information on the service eligibility for organisations in their country (as defined in the GenoEx PSE Business Rules)

ICAR/InterBull Task Force(IC-IB TF) – the first conference call/meeting was held on 18th December with Hans, Martin, Marco, Reinhard, Toine and Brian van D. In the first instance the Terms of Reference were reviewed and refined. Key next steps will be for Martin and Toine to identify key processes for review in the IC-IB TF's face to face meeting planned for Verona Feb 03rd 2016. Ultimate goal is to have final report on IC-IB synergies to ICAR Board at Chile 2016.

Ongoing Communications: Martin and Toine continue to hold regular (monthly) Operational conference calls to be sure communication is maintained both ways

between Uppsala and S-ICAR to ensure administrative cooperation, last calls were Dec 12th 2015 and next call/meeting Jan 11th 2016.

6 ICAR 2018 and 2019 Conference – Host Selections / Options

In our Nov 20th 2015 meeting the Board asked Jay Mattison, Bevin Harris, Martin Burke and Brian Wickham to meet and recommend a suitable location for ICAR 2018 and 2019 Conferences.

ICAR 2018:

The group convened two conference calls (Nov 30th and Jan 6th) as well as various telephone calls with staff and other stakeholders. As a result have the following recommendation;

For ICAR 2018 we should coincide with the World Congress of Genetics (WCG) but rather than joining up with the WCG at the same venue (which is in Auckland from Feb 11th to 17th 2018, - that instead we have **our own** conference nearby in Hamilton or Rotorua (some 150km-200km away) during the preceding week. So ICAR 2018 would run from say from Wed 7th to Fri 09th Feb 2018.

Rationale is as follows;

- WCG is a big event with some 1300 expected we could get "lost" in it if we are on same site
- By holding and hosting our own event in near but separate location we maintain our independent "brand"
- Auckland is a big city and Hamilton or Rotorua are smaller and in the former's case is in a Dairy area - more suited to our members business
- Will suit Interbull SC and geneticists as they can easily schedule both in same trip
- We could work with WCG LOA to have joint session on Genomics on the Mon 12th in their session
- We could work with WCG LOA to use one Technical Tours outing schedule instead of having two
- I believe we will have enough support from ICAR local members LIC, Milk Test NZ and Assoc members like Waikato, etc - an all NZ approach
