EXPLANATORY NOTES TO THE FINANCIAL STATEMENTS

For the period 1st January to 31st December, 2015

NOTES – Balance Sheet

1. Cash

Includes cash on hand current bank account balances (cash, BNL and DBI).

2. Membership Fees Receivable

According to the ICAR rules, those members with two years of arrears have been frozen in 2015, while those full members with 2015 outstanding fee are not allowed to vote at the General Assembly in Puerto Varas.

In this item the 2015 fees outstanding at 31/12/2015 were accrued for an amount of $\in 37,956$, while $\in 7,429$ corresponds to the outstanding fees for previous years (the composition is attached as annex 1).

3. Capital Assets

Net book value of computers and furniture owned by the Association (cost less depreciation).

4. Investments

The Association sold its investment in October 2015 which is now in the current account at DBI. The market value was €245,197.60 while the face value originally was €248,000.

5. SERVICE-ICAR Srl Shares

The amount of €10,400 represents the share of capital in the business company "SERVICE-ICAR S.r.l." owned by the Association. The amount is unchanged since the creation of SERVICE-ICAR Srl in 2001.

6. Prepayments

In 2012 and 2013 the Association renewed for 10 years the protection of its marks and logos, ICAR and Interbull, in those countries where the registration was on deadline. The total amount paid was split over 10 years to cover the validity until 2022-2023.

In 2013 the Association started the same process to protect the name and logo of InterBeef, the total amount paid was also split over 10 years to cover the validity until 2023.

The amount left in 2015 is \in 18,185.

7. Other debtors

The credit for social charges and taxes related to 2015 amounts to €2,780 and the amount to be received for the LoA with FAO for the Symposium in Pretoria is €10,180.

8. Accounts payable

These are payments due to customers paid in January 2016 for an amount of €19,772.56 and to the Italian taxes and social charges for an amount of €8,108.93.

9. Prepaid membership fees and deferred income

10. Severance Reserve Fund

The Association is required to collect and accumulate prescribed annual amounts as they relate to permanent employees in accordance with the legal requirements of Italy. Those amounts will be retained by ICAR and shall be dispersed to the employees when they will leave the organization.

NOTES: Statement of Financial Position (Income Statement) related to the 12 months budget

1. Membership Fees

This is the total amount already received for 2015 fees.

2. Membership Fees receivable 2015

This is the remaining amount due for arrears of 2015 by members.

Compare to the budget, the total income for membership fees in 2015 is higher than budgeted; this is due to new members which applied in 2015.

3. Other projects

This is the amount received from FAO for the LoA to organise the Symposium in Pretoria in April 2015.

4. Other contributions

This is the contribution paid by SLU/Interbull Centre. It is slightly less than budgeted as EAAP resigned in 2015.

5. Investment Income

The 2015 investment income of €1,336 is referred to the period until October 2015 when the investment was sold.

6. Travel and Meeting Expenses

Costs related to travel and accommodation from the Secretariat, Board and Executive Board, and General Assembly.

7. Technical activities support and Future ICAR

The total amount includes the support to the Groups (\in 1,619.20) and the cost for Future ICAR (\in 34,820.45).

8. Bank Charges and Investment Expenses

Expenses charged by the bank BNL and DBI for current accounts and for the investment portfolio administration until October 2015.

9. Bad debts

This is the total amount of outstanding fees due by the members frozen in 2015 (see annex 1). According to the ICAR rules these members have been cancelled and their dues put in the financial statement as debt.

In accordance with the new Statutes starting 2015 the fees due by an associate member have not been accrued.
