3 Brand Project Action Plan

4.2 **New Members**

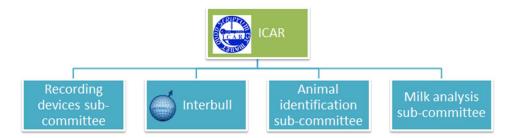

5 Groups Update / Report

Reports from ICAR's 4 Permanent Sub Committees;



5.1 Milk Analysis SC

S-ICAR PT: March 08th 2016 saw the first ICAR PT samples dispatched under Service ICAR. Some 27 participants are taking part in this March run. Once results are back the Performance Reports will be sent from Service ICAR with subsequent invoices to follow.

S-ICAR & European Milk Recording (EMR) – S-ICAR in partnership with EMR and others are submitting a Joint Project application to FTI Horizon 2020. (The Fast Track to Innovation (FTI) pilot is a fully-bottom-up measure in Horizon 2020 to promote close-to-the-market innovation activities).

EMR (www.milkrecording.eu) was created in the continuation of OptiMIR. The objective is to deliver a marketable standardisation service to milk laboratories, Milk Recording Organizations, dairy industries and other stakeholders who use MIR technology.

S-ICAR's primary role is in Work Package (WP) 4 to provide standardisation and certification services to validate the new EMR algorithms for Milk Analysers. S-ICAR also has a secondary dissemination role in WP 5.

Reference **Appendix 6. FTI EMR Budget Summary Project Submittal** for details of the budget submitted with a total of €196,500 budgeted for S-ICAR.

Reference WP details on Pages 31-34 of **Appendix 7. EMR Project Proposal Full Text (sent in 15/03/16)** which covers summary of S-ICARs tasks.

We don't expect the final decision on this from FTI until Autumn 2016 and as such we don't see any impact on the Service ICAR budget in 2016.

5.2 Recording & Sampling Devices SC

In March 2016 the Recording & Sampling Devices SC sent out two Annual Letters;

March 29, 2016

- 1) Manufacturers letter requesting manufacturers to review their list of Certified ICAR meters and inform us if they are still current or indeed have had any modifications as per section 11.5.4.1 of our guidelines.
- 2) Members Letter requesting members for field feedback or dissatisfaction ratings on devices in use as per our guidelines section 11.5.4.2. Request: If such a letter is relevant to your organisation (and not already dealt with by your organisation), then it would help Steven and the SC if Board members could follow up internally to help get these reports back. (See **Appendix 8.** for copy of the Members letter).

5.3 **ID Devices SC**

ICAR Office continue to support the ID SC on main topics of a) documenting key ID certification SOP's, and b) assist the revamp of the ID certification listings on the web site.

Note: Ken Evers Chair has relocated to USA – Martin has been speaking with Ken in last weeks and from end of April onwards it seems he has no mandate from an ICAR member to continue as chair (He tells me it is also unlikely he will find relevant work with a member). As such CE, Brian and staff will start making plans for filling this position as a priority. CE to oversee and continue to advise Board on this key position.

5.4 Interbull

GenoEx PSE-Implementation Task Force (PSE-ITF) held a subsequent meeting on March 17th - Main topics being worked on are;

- Wording of service agreement working on roles and responsibilities between ICAR, Interbull Centre and User.
- Define Service fee structure
- Wording for contacting ICAR members to inform them of GenoEx PSE and for requesting information on the service eligibility for organisations in their country (as defined in the GenoEx PSE Business Rules)
- Define authorities and their accredited / appointed labs for usage of data and access rules for which ICAR will maintain register.

A further PSE-ITF meeting is planned in April. Goal is to have a service agreement proposal for ICAR Board review at "face to face" in Amsterdam on May 27th 2016.

ICAR/Interbull Task Force(IC-IB TF) – following on from Verona meeting in February, the ICAR/Interbull task force held a conference call on March 16th.

March 29, 2016

At that meeting, Martin/Toine gave update on progress on the first priority which is the Business Processes review. Good work is underway, we now know all 34 Interbull clients are indeed ICAR members and we are currently working to standardise and define clearly the figures that are used for Interbull fees as set down by Interbull SC.

Hans Wilmink made the point that the Task Force should focus on the "as is" and develop an executive status summary for our next meeting on April 18th to report on progress, ensuring we keep to original Terms of Reference.

It was also decided in the upcoming "face to face" ICAR-Interbull TF meeting which is scheduled on the afternoon of May 26th (day before ICAR Board on 27th) that we dedicate half that meeting to address 'process' and the other half to 'governance'.
