CE Commentary;

The current estimate for Service ICAR's 2016 year end P&L position shows a loss of -€93,505 (which is -€39,765 worse than the Approved Budget of -€53,750). The main contributor to this 'worse than budget position' is due to Service ICAR taking €35,000 of ICAR Brand 2016 Project costs. (Under line item "Technical Activities and IT Support" in P&L statement).

CE and ICAR team will work to try and minimise this shortfall in the remaining 7 months of 2016, by following actions;

- Increase ID activity/income through new Validation Service for Competent Authorities
- 2. Increase Interbeef membership through engagement and sign up of Australian beef members.

Continued monthly review and actions by CE and team. A further formal report to Service ICAR Board planned for end of September 2016.
