1.4 New Quarterly Financial Reporting Templates

The existing Board Financial Reports of Balance Sheet and P&L have been reviewed and endorsed by Deloitte. They say these are in line with International Standards. We will continue to use these as is but will now make available Quarterly Reports to Board(s).

What the CE and Elena have asked Deloitte to provide Service ICAR is;

- 1) A more 'automated' monthly bookeeping template clear and 'single key' entry from Italconsultants to ICAR staff. This will faciliate monthly reporting to CE.
- 2) New Monthly Management Report on P&L with Overheads allocated. Looking at Service ICAR first, Deloitte have developed a Financial Reporting template based on Revenue as the driver, apportioning overheads according to activities as in the files supplied by ICAR.

3) New Cashflow Monthly Budget and Report – this is under development in next weeks and the plan is to have it in place for 2017.
