1 Priorities

- ✓ Building ICAR's QMS in line ISO 17065 ICAR ISO accreditation for S-ICAR as a Certification Body (CB) review further in 2017.

5 Board & Chairs Meeting - Follow up

After the ICAR Board & Chairs meeting held in Chile we conducted a survey to get the participants reactions/input. The full results of the survey are attached (**Appendix 1**) with the key points of feedback summarised as follows;

- 1. The meeting was very valuable, there is confidence that ICAR is now on a good path and that the Board acts on the feedback given at these meetings.
- 2. The Group reports are valuable, and more time should be given to discussing them in future either in this type of meeting or through video conference. We need to ensure we clearly hear the views of the Group Chairpersons.
- 3. The Guidelines workshop was well prepared, and ICAR should now place priority on improving the Guidelines.
- 4. A similar meeting should be organised for next year in Edinburgh and ensuring a room which is a little larger with better layout, light and ventilation.

CE, Groups Coordinator and ICAR team will now begin to work on the Guidelines 2017 Project.

6 Groups Updates

6.1 Milk Analysis SC

Preparations are ongoing for our special PT ring test for extra parameters planned for December/January.

CE and Silvia working on 2017 Strategy Document for ICAR MIR Equipment Validation scheme.

6.2 Animal Identification SC

An informal meeting of SC members was held in Chile which was followed by a Manufacturers meeting. Items discussed were;

- ID Country code issues with Interbull / Intergenomics mini team to review
- Promotions Advisory Group for 2017 ICAR Certifications Services
- UHF Code numbering global standard group

These key issues and other routine matters will be discussed in our scheduled ID SC meeting on Dec 12th 2016.

The CE has had some discussions with relevant Board members re possible new Chair for SC ID – plan is to make a proposal to the Board in the New Year.

6.3 Recording & Sampling Devices SC

6.3.1 **Sensor TF**: On 11th Nov the Sensor TF had a conference call. The following are key actions arising;

- Develop initial 'working' list of Sensors/Systems in our markets (Clement/Kees/Uffe)
- Do a trawl of recent research/studies on Sensors and summarise Karl/Silvia.
- Prepare a survey to establish what sensors our DHI members are dealing with in the field. (Martin/Brian/Steven)
- Short survey to other SC' and WG's on which traits are priority. i.e. to Interbull, Interbeef, Feed & Gas, ADE, etc. (Martin/Brian/Steven)
- Reach out to include more Manufacturers / Technologists into TF at moment only Lely need to include others (Uffe/Steven).

Follow up on above at next Sensor TF meeting scheduled for 16th December 2016.

6.3.2 **RSD SC Nomination**: The SC Chair requests the board to accept nominee Danuta Radzio of the Polish Federation of Cattle Breeders and Dairy Farmers, to be a member of the Recording & Sampling Devices SC. There was an expressed interest to bring expertise from Central/Eastern Europe to the team since the departure of Vladimir Tancin.

Steven's comments "Based on informal discussions with other RSD-SC members, it was an easy decision to approach Danuta about our work. Danuta will bring expertise, complement the group's skills, and will help share the heavy workload ahead for the group which includes guidelines revisions, sensor device guidelines, and AMS shuttle testing. This will be the final member of the RSD-SC."

Attached is a CV from Danuta (Appendix 2) and we also received a letter of support from Leszek Hądzlik, President, Polish Federation of Cattle Breeders and Dairy Farmers for Danuta. Steven visited in person with Mr. Hądzlik, outlining the commitment that includes conference calls as well as face-to-face meetings in Rome (February) and Edinburgh (June).

6.4 Interbull/Interbeef

- 6.4.1 **Interbull:** The ICAR Interbull TF met on Sat 22/10 in Chile the list of actions agreed which was later endorsed by the Board at its 23/10 meeting. Agreed to focus on rewrite of the ICAR SLU agreement as a priority. The next TF meeting is on December 09th at 1400hrs. The goal is to complete TF by Edinburgh (June 2017).
- 6.4.2 **Interbeef**: New Interbeef agreements (1.ICAR-SLU and 2. ICAR-Client) were presented and reviewed by the Interbeef WG in Chile. Some changes were recommended by the WG and these were brought back to Irish legal advisor on 09th November. Subsequent changes were incorporated and final drafts are now for review by Interbeef WG. Once accepted there, the new agreements will be presented to the CAR Board for adoption for 2017.

6.5 Other Groups Updates

6.5.1. **DNA Working Group formation** – CE and Brian Wickham approached Brian Van Doormaal in Chile and asked him to chair the new DNA WG. He accepted. We now recommend to the Board that Brian Van Doormaal's Chairmanship be approved We also ask the Board for the approval of the Group Members as nominated and listed in Table 1.

7.3 **ICAR 2018 NZ:**

WGALP and ICAR LOC's agreed that we should use a shared infrastructure for promotion, marketing, sponsorship, registrations, program, presentations, social functions and conference tours.

Doing this will: a. reduce the administrative burden of hosting and b. enable us to provide a better conference experience for both of the WCGALP and ICAR

communities. This means we will have a joint conference of ICAR and WCGALP in Auckland. There will be no loss of identity for either, we will maintain separate budgets for each LOC, we will attract a larger audience to both and we will gain some operational efficiencies and cost savings which will be shared. The program structure will **not** change.

7.4 **ICAR 2019**:

LOC being formed January 2017 – expect final decision on Czech city and dates will be announced February 2017.

7.5 **ICAR 2020**:

Board sub group of Niels, Bianca and Japie + ICAR staff will hold an 'ICAR2020' Conference call on Fri 16th December at 0900hrs CET (Rome). Initial thoughts are to look at Belgium and/or Netherlands for ICAR 2020 – especially interesting as in 2020 we will have Interbull full sessions with our ICAR conference.
