Deloitte Audit March 06th - I can confirm that Deloitte will be conducting a full "Audit". From meetings with Deloitte on January 19th. I can also confirm that both ICAR and Service ICAR will be covered. Cost to cover both come to €9,500 exc VAT. The value of an ICAR only audit without SI is largely optical but putting Service-ICAR with it makes it more meaningful and a more forensic audit.

Deloitte Audit reports will be sent to ICAR Inspectors for review rather than have Josef or Neil coming to Rome - based on this year experience we will review what is necessary for 2017.

4.4 Interbull/Interbeef

- 4.4.1 **Interbull:** The ICAR Interbull TF met again on 19th January 2017. The rewrite of the ICAR SLU agreement is a priority. A mini group of Martin, Reinhard, Toine and Brian W have been asked to work on updating the agreement. Meetings were held 13th January and Feb 01st 2017 to address this item and progress is being made with initial draft underway. The full TF met is on January 19th and next meeting is scheduled for Feb 16th at 1400hrs. The ICAR –SLU agreement is the immediate priority. The overall goal is to complete TF by Edinburgh (June 2017).
- 4.4.2 **Interbeef**: New Interbeef agreements (1.ICAR-SLU and 2. ICAR-Client) were presented and reviewed by the Interbeef WG. Final drafts are now for review in context of the ICAR-SLU agreement work in 4.4.1 above. Once ready, the new agreements will be presented to the ICAR Board for adoption for 2017.

4.5 Other Groups Updates

- 4.5.1. **DNA Working Group** the ICAR Accreditation of DNA Centres is subject to the release of a new data file by Interbull which is currently under test. Three members have applied for Accreditation, namely, VIT, CONAFE and ANARB. Ongoing.
- 4.5.2. **Breed Association (BA) WG** with the resignation of Matt Schaffer we are proposing a call for replacement see attached **Appendix 1. BA Chair Job Description** and **Appendix 2. Terms of Reference** for Board review.

LOC being formed January 2017 – expect final decision on Czech city and dates will be announced February 2017.

5.4 **ICAR 2020:**

Board sub group of Niels, Bianca and Japie + ICAR staff unanimously agreed that we should pursue Netherlands in the first instance for ICAR 2020, especially so as in 2020 we will have Interbull full sessions with our ICAR conference.
