4 Groups Updates (Item for Board Info only)

4.1 Milk Analysis SC

Gavin Scott has resigned as Chair of the MASC. The call that ended on Sept 08th yielded zero applicants.

ICAR needs to give new life to the MA Sub Committee.

I believe our first priority should be to get some new members into the MASC.

Steps to recruit members:

- 1. Silvia in the first instance to send a 'call' to all the 50 lab managers who participated in the 2017 ICAR PT. (Silvia has been supporting these lab managers active in ICAR) (Sept)
- 2. Martin/Silvia/Harrie to review this list and make a short list of people to 'target' for personal follow up call. (Oct)
- 3. With respect to Chair will ask the MASC to rotate the chairing of next few MASC meetings among the members until we arrive at a suitable chair candidate. This will give us time while achieving the more important task of building capacity and enthusiasm within the group.

4.2 Animal Identification SC

CE had a good call with Jo Quigley on Sept 12th and can report she has accepted the position of Chair.

CE met with ID Manufacturers Allflex, Datamars and Caisley in Dublin on Sept 08th at their request. Agenda items were 1. Competent Authorities lack of engagement with ICAR and 2. Quality in the Field. Further meeting scheduled for Nov 6th which Jo and CE will attend and report back to SC.

The file is currently being tested by members including VIT. No report since August update.
