ASSETS

Current assets

1. Cash

Includes cash on hand and current bank account balances.

2. Member fees receivable

Includes members with maximum two years of arrears in the current financial year. Outstanding fees are presented in Annex 1.

3. Other receivables

These are credits to be received from the Italian tax office.

4. Prepayments

The Association owns the ICAR, Interbull and InterBeef logos. The ICAR brand and logos were redesigned and registered in 2016. A summary and calendar of annual depreciation is presented in Annex 2.

Non current assets

5. Fixed assets

Net book value of computers and furniture owned by the Association (cost less depreciation).

6. Financial assets

The amount of €10,400 represents the share of capital in the business company "SERVICE-ICAR S.r.l." owned by the Association. The amount is unchanged since the creation of SERVICE-ICAR SrI in 2001.

In addition, there is the deposit with ExecutiveOffice for an amount of €1.300,00 for the rent of one room.

7. Accounts payable

Invoices related to 2017 business activities but to be paid in 2018 (e.g. employees, consultants, and operational expenses).

8. Deferred income

In 2016 there was a partial advance payment for 2017 membership fee from a member.

9. Summary of investments

Reserves

Total reserves: 14.2 months (policy target of 6 months)

Liquid reserves: 14.2 months equivalent (policy target of 3 months)

INCOME

1. Member fees

This is the total amount received from member for annual fees and SLU contribution.

EXPENSES

2. Employees and related expenses

Expenses related to management and administration including staff, consultants, and contracted services (€91.500 in services contracted from SERVICE-ICAR SrI in 2017).

3. Travel

Total cost for travel, accommodation and meals of the office, Board, and General Assembly.

4. Office

Total cost to run the office (postage, telephone, office material, printing, Web site, etc.) including rent in an amount of €9.760.

5. Administrative services

Cost for outsourcing services (accounting, legal, etc.). 2017 included an unbudgeted expense for the new registration of logos in an amount of €14.849.



6. Depreciation

Depreciation for the year of computers and furniture owned by the Association.

7. Special projects expenses

Here below the breakdown for the special projects:

- Video prepared by QLip for the Sub-Committee Milk analysis for an amount of €2.420.
- Guidelines project (Mark Partners) for an amount of €12.100.
- Partial reimbursement to SERVICE-ICAR SrI for Sub-Committee Recording and Sampling Devices (RSD) study prepared by *Institut de l'Elevage* for an amount of €6.100.
- IT support by C. Melis for Proficiency test activity and RSD web site for an amount of €6.724.64.
- Development Cuckoo Parentage Verification by Canadian Dairy Network for an amount of €4.030.
- Travel expenses for meeting of RSD and Task Force of Sensor devices for an amount of €1.639.

8. Other extraordinary income / (expense)

Expenses not budgeted with detail below and bad debts for outstanding fees. .

- Unexpected legal and travel costs for an amount of €16.749.
- Theft in the office for an amount of €375.
- Bad debts for two members frozen in 2017 for an amount of €8.894 (Annex 1).

9. Investment income / (expense)
