7. Sub Committee / Working Group Updates

CE and Groups Coordinator will be conducting 'one on one' meetings with all SC/WG/TF **Chairs** in the last two weeks of September. We have three items on the agenda for these meetings:

- a. Review of Priorities for SC/WG/TF.
- b. Procedures for maintaining the Guidelines.

We have set aside the last two weeks of September (the weeks starting Monday 17th and Monday 24th) for these meetings.

7.1 Animal Identification SC

ICAR has had a meeting with Datamars staff to begin the transfer of the **Search Function for ISO Registered Codes.** An ICAR ftp site has been created and we are awaiting transfer of the software and files to tun the ISO registered device search – upon receipt we will begin to incorporate this search function back into ICAR's website as we are the ISO Registration Authority (search was formerly run by Planet ID).

ICAR has been working with Manufacturers on developing a **New Guideline for ID Tag Field Trials**. Meeting was held on August 14th to review the latest draft – Manufacturers are happy with progress and now we will finalise with the ICAR ID SC and bring to the Board when ready (September or October latest)

The **ISO WG 3** will be meeting in Giesen, Hanover, Germany on Oct 16th and 17th 2018. Andie Dimitriadou of ICAR staff will attend.

7.2 Recording & Sampling Devices SC (for Board Approval)

There is a new nominee/candidate from LIC to join the Recording & Sampling Devices SC. Mr. Andrew Scott is the Herd Testing Quality Manager with LIC. His Curriculum Vitae is attached. (Appendix 6), as well as supporting letter from LIC Management (Appendix 7). The Chair of the RSD SC and the CE would like to recommend to the Board to accept Andrew as a member of the RSD SC.

7.3 Milk Analysis SC

MA SC have convened a meeting for September 12th, 2018. The SC will rotate the Chair for all meetings until Prague 2019 at which time it is envisaged that Michel Grise will take over the Chair.

The ICAR Proficiency Test (PT) autumn call has been sent out and so far some 43 laboratories have indicated they will participate.

7.4 Interbull
