4.2 Recording & Sampling Devices SC (for Board Approval)

Nominee for SC Membership: There is a new nominee/candidate from IDELE to join the Recording & Sampling Devices SC. **Mr. Alain Gastebled**;

« Alain Gastebled started his career as a dairy farmer. After 6 years he decided to follow another way and worked as local advisor for a milk recording organisation. Then, he was recruited by the Institut de l'Elevage as national inspector for milk recording from 1997 to 2007 where he was specialized in the control of milk recording devices. During this period he was also instructor and he trained French MRO's technicians to control milk meters.

Since 2008 he is involved in the ICAR approval process of millk recording devices for the French Test Center. In the last years, he actively participated in several ICAR tests (OriCollector, LCS, MMV,). At the same time he also manages the field certification of new identification ear tags in France. Alain already knows the ICAR MRSDSC, as he temporarily participated between 2008 and 2010. »

ICAR 2019 CZ: 16th - 21st June 2019

June 16th-21st 2019 (ICAR to run from Sunday 16th til Fri 21st June 2019. Starting with Board Sun 16th June 2019, Mon Tue SC/WG meetings and conference Wed 19th – Fri 21st.

IDF Analytical Meetings in the days Fri 21st til Tue 25th June 2019.

ICAR and LOCCZ have signed Conference agreement February 2018

ICAR-LOC2019 calls ongoing monthly. CE met with Pavel Bucek in Rome on Oct 16th to review program – draft of which will be shared with Board on Nov 12th 13th 2018

ICAR 2020 NL: 07th - 12th June 2020.

Location Leeuwarden, Netherlands now confirmed with dates from 07th – 12th June 2020. Initial skeleton program under discussion with LOC2020 ICAR and Interbull.

Interbull Director to be part of ICAR team to liaise with LOCNL as programme is prepared.

LOC 2020 met in June and ICAR agreement has been reviewed and signed off by CEO of CRV – CE is visiting CRV on Oct 22nd and will attend LOC2020 meeting in Arnhem that day.

ICAR 2021 & 2022:

ICAR 2022: CE has sent letter to the three General Managers of our Canadian ICAR members (Canadian Dairy Network, CanWest DHI, and Valacta) asking them to discuss with their respective Board to discuss option of Canada hosting ICAR 2022 – await confirmation from Canadian members.

ICAR 2021: As advised RSA will not host 2021.CE convened the small board group of Bianca, Japie and Jorge on Oct 5th to review options re alternative host. We decided the Iberian Peninsula was a good target. 1st option was Portugal but as EAAP are there in 2020 we felt it was too close. Next option is for CE to contact our Spanish members – call with CONAFE, FEAGAS etc. – CE to provide verbal update.
