6. Administrative services

Cost for outsourcing services (accounting, legal, bank expenses, etc.), including 28.340 Euro for extra legal fees.

7. Special projects expenses

These are the special projects budgeted in 2019:

- 1. Recording Devices Projects/Test Lab S/W upgrades (€14k).
- 2. CDN Parentage Discovery S/W (€6k).
- 3. Transfer of the seat (€30k).

In this period there is 3.806 Euro expenses are related to special project 1, and 14.985 Euro to special project 3.

1. Cash

3. Prepayments

The Association owns the ICAR, Interbull and InterBeef logos. The depreciation of the cost is over 10 years. This is the total amount remains.

4. Fixed assets

Net book value of computers and furniture owned by the Association (cost less depreciation). Nil in 2019.

5. Financial assets

The amount of Euro 10.400 represents the share of capital in the business company "SERVICE-ICAR S.r.I." owned by the Association. The amount is unchanged since the creation of SERVICE-ICAR SrI in 2001.

In addition, there is the deposit with ExecutiveOffice for an amount of Euro 1.300 for the rent of one room.
