Introduction

On December 12th, 2019, ICAR was registered in The Netherlands and for 2020 will operate under Dutch law as an association with a trade number for its paid services.

As such, 2019 will be the last year where FULL Annual Financial Reports will be issued for ICAR and SERVICE-ICAR Srl.

In 2020 there will be a financial statement for ICAR operating in Italy from 1st January until its official closure and another financial statement for ICAR operating in The Netherlands starting after the closure in Italy which will include the paid services.

SERVICE-ICAR Srl will present its financial statement 2020 from 1st January until its official closure.

From 2021 on there will be only a financial statement for ICAR with one single balance sheet and profit and loss account.

REVENUES

1. Membership fees

Total amount from membership fees.

2. Special projects and other income

As per agreement, payment of 10.000 Euro received from Czech Moravian Breeders' Corp. for the organisation of the ICAR Annual Conference.

Payment of 5.502 Euro received as partial reimbursement of legal fees for the AR case as established by the Court. Reimbursement of 1.550 Euro from NDHIA to support participant in Prague.

EXPENSES

3. Contracted consultant costs

Expenses related to the management and administration including the Chief Executive and other consultants for an amount of 85.793 Euro, and contracted services paid to SERVICE-ICAR Srl for an amount of 91.463 Euro.

4. Travel

Total cost for travel, accommodation and meals of the office, Board, Groups and General Assembly.

5. Office

Total cost to run the office (postage, telephone, office material, printing, Web site, etc.), including rent. In 2019 there was an extra cost for renting in Utrecht for an amount of 2.904 Euro.

6. Administrative services

Cost for outsourcing services (accounting, legal, bank expenses, etc.), including 28.406 Euro for extra legal fees.

7. Special projects expenses

These are the special projects budgeted in 2019:

1. Recording Devices Projects/Test Lab S/W upgrades (€14k).
2. CDN Parentage Discovery S/W (€6k).
3. Transfer of the seat (€30k).

In 2019 there were 20.606 Euro expenses related to special project 1, and 22.635 Euro to special project 3. Project 2 was deferred to 2020 and delivery is expected in QTR 1/20.

In addition, there was a special grant of 15.000 Euro to support a Research and Development PhD programme in Wageningen/ICBF/Interbull aimed to provide the InterBeef Working Group with the roll-out of International genetic evaluations for beef cattle, through ICAR/Interbeef. This will be across many traits, breeds and countries. Key goals of the R&D include:

- A rapid system for the routine estimation of genetic parameters at the Interbull centre.
- Estimation of genetic parameters for new traits/countries.
- Use of genomic data in the estimation of genetic parameters.

8. Bad debts

The Association owns the ICAR, Interbull and InterBeef logos. The depreciation of the cost is over 10 years. This is the total amount remains. In addition, there is a payment for an amount of 4.174 Euro for the new contract at HNK Utrecht for deposit and renting office in January 2020.
