## Agenda

The agenda was approved as proposed.

### • Terms of Reference ToR of the Governance Committee

The Code of Ethics mentioned in the ToR is unknown. This will be looked up and shared along with the minutes as well as a draft of the Terms of Reference of the Governance Committee.

João Dürr wonders if the supervision over the SC's and WG's is included and if Interbull is different from the others. Is there a maximum term for each group member? Group governance should be covered.

Martin Burke indicates that each group has a ToR. There is no need to change those if they work.

## Financial Inspector - Call for Nominees

The document regarding the call for candidate financial inspector is being reviewed and will be tidied up and presented for approval at the Board meeting in November.

#### Interbull Terms of Reference

João Dürr indicates that this document is from after his departure. Joao suggested we get to see a version with changes so it will be easier for Board review. Martin Burke will ask Toine for a summary of the changes.

The agreement between SLU and ICAR is guiding for the ToR. Martin Burke will share the recently signed agreement with SLU as well as the ToR with the Board in November. It will be a lot of work to review the Interbull ToR. Martin will recommend to Board in November that João Dürr is asked to attend the Interbull-ICAR Comms meetings.

The following matters require particular attention:

- Point g.: ... the maximum number of years that a person may serve on the SC is
  - 15 years.
- Table 1: 'two representatives for North and South America'

## How we can better engage with our Associate Members at Board level

João Dürr notes that it's about positioning; they are always welcome to participate. They have an opportunity to have a voice! We should improve communication.

Jason Archer believes that it is more about WG level than Governance level 'independence'-self regulated. We need to be careful.

António Martins sees no problem if they want to participate in WG or SC, but not in the board due to possible conflicts of interest.

Martin Burke says we cannot be naive here. ICAR should ask the Associate Members what they want, but ICAR needs to control the level of independence and is therefore reluctant. Big money speaks.

João Dürr says we need to establish a good definition of a full member and an associate member for discussion with the Board and asked martin to include for November
